

To register you must approve all the following REGULATIONS:

_The holder and Administrator of the blog/post for money www.sonopigr.it is Sono pigr S.r.l.;

_Participation in the blog implies that the user has accepted all the conditions in the regulations.

_The Administrator can modify and/or supplement said regulations. In this case an e-mail will be sent to the registered users asking them to read the modified regulation. The use of the blog by the user after said modification will be considered tacit unconditional acceptance of the new conditions.

_No responsibility shall be taken by the Administrator regarding the contents posted on the blog because it is impossible to exercise preventive control over said content (pursuant to art. 14 and 15 Directive 2000/31/CE); the posts are directly edited and made public by the users themselves and therefore said user assume all responsibility for approving this regulation (accepted by everyone during registration).

_Every user who encounters content that is illicit, detrimental or suspected to be non-original has the right to report it to the editing office of Sono pigr S.r.l. at the following e-mail address: info@sonopigr.it.

_The theme of the contest is monthly and will be published at 12 o'clock midnight of the first day of the month. Posts will be accepted until 11:59 p.m. of the last day of the month.

_The posts can be in the form of writing, images or videos. The user is allowed to enter an unlimited number of posts. However, the repeated entry of posts having similar content may influence the judgment of Sono pigr S.r.l. in awarding the prize and could lead to the cancellation of the posts.

_The posts must contain original content. The user is the only person responsible for the originality of the content posted and in cases of plagiarism said user shall be personally and directly liable to third parties who hold the copyright. Sono pigr S.r.l. does not assume any responsibility for the originality of content.

_It is allowed to comment on the posed by another user but mere a comment on a post does not constitute participation in the contest. In cases where a commented post wins, the comment itself can be published in the Annual but will not receive the monthly prize of 250.00 euro (which will be paid only to the winning post). Nor will the comment be paid any royalties on the profits deriving from the sale of the Annual.

_The monthly winner will be announced by the 15th of the month following that of the posts according to the irrefutable judgment of Sono pigr S.r.l.; the prizes for winning are the monthly sum of €250 and publication of the post in the Annual. The published post will be paid royalties on the profits deriving from the sale of the Annual. The price to the public for the Annual shall be established exclusively by Sono pigr S.r.l. at the end of the 12-month contest.

_Sono pigr S.r.l. reserves the right to vary the value and number of prizes and can decide not proceed with publication of the Annual.

The win can be formalized only after the participant signs an agreement with the following principal stipulations that require the participant to:

1. Provide all personal data of the participant not supplied during registration at the blog required in order to formalize delivery of the prize and the business relationship regarding publication of the Annual;
2. Take responsibility for the originality of the content of the awarded post published on the website www.sonopigr.it (and associated domains) and in the Annual.

_The winner may be asked to pose for a photograph for the purposes of publication in the Annual or, if unable to have a photograph taken, provide a portrait having a resolution sufficient for high-quality printing

according to the needs of the graphics project commissioned.

_In cases where a post/video wins, only a few stills will be published in the Annual and an accompanying text will be requested of the author.

_The obligatory and public information about users for each post are: nickname, date and time of posting, the number of comments on the posts and the status of the revision if it is a revised post. All other information is optional and will be managed directly by the user's control panel.

_Sono pigr S.r.l. also reserves the right to publish in the Annual the posts of non-winners who shall nonetheless have no right to claim payment for publication.

_The TopTen is not a graduated list but a temporary updated selection of the 10 best posts regarding the theme in progress. Once the TopTen is transferred to the Archives area, it shall only indicate which of the 10 posts was awarded as the winner.

_The Archive will keep all the posts of the month for the entire subsequent month after closing the theme contest. Afterward only the TopTen will be present.
